The Pre-Registration Educational Course will be conducted by expert faculties who would share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

In view of the current situation of COVID-19, and as per the IBBI Circular dated 10th July, 2020, which states that the mandatory 50 Hour training of Preregistration Educational Course will be to continue online delivery of education beyond 30th September, 2020, in addition to classroom mode, wherever possible. These classes will be conducted online.
