The Pre-Registration Educational Course will be conducted by expert faculties who would share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

In view of the current situation of COVID-19, and as per the IBBI Circular dated 29th March, 2022, which states that the mandatory 50 Hour training of Pre-registration Educational Course will be to continue online delivery of education till 30th September, 2022, in addition to classroom mode, wherever possible. These classes will be conducted online.
