

**PRE-REGISTRATION EDUCATIONAL COURSE**

Madam/Sir,

At the request of prospective participants, ICSI Institute of Insolvency Professionals (ICSI IIP), jointly organising the **21<sup>st</sup> Batch of Pre-Registration Educational Course** (“Course”) at **Kolkata** proposes to tentatively conduct the program between **05/08/2019 to 11/08/2019, subject to:**

1. **A minimum number of 20 participants, enrolled with all the three IPAs, joining the program.**
2. **Confirmation for holding of the batch from 05/08/2019 to 11/08/2019 will be informed to the participant’s on 25<sup>th</sup> July 2019, subject to (1).**
3. **Any expenses incurred for travel/stay bookings by outstation participants prior to confirmation by the respective IPAs before 25<sup>th</sup> July 2019 will be at their own risk.**

**Purpose**

The Insolvency and Bankruptcy Board of India (“**IBBI**”) has introduced a Pre-Registration Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations, 2016.

With effect from 1<sup>st</sup> April 2018, individuals are eligible to register themselves as Insolvency Professionals (IP) only after undergoing the **mandatory** Pre-Registration Educational Course from an Insolvency Professional Agency after his/her enrolment as a Member.

The classes of the Pre-Registration Educational Course will be taken by expert faculties who would share their varied experiences. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

All the three IPAs viz. ICSI IIP, IIIP of ICAI and IPA ICAI (Cost), are jointly conducting the Course as detailed below:
